

# Letter from the **EXECUTIVE DIRECTOR**

In 2022, our community transitioned from a pandemic to an uncertain economic climate. As the designated Community Action Agency for El Paso County, Project BRAVO is dedicated to meeting struggling families where they are at and offer services that provide opportunities for economic self-sufficiency.

Project BRAVO met many challenges, including distributing additional federal grants, such as funds from the American Rescue Plan Act (ARPA) of 2021. One critical ARPA program implemented in 2022 was the Low Income Household Water Assistance Program (LIHWAP). The LIHWAP program was developed from the ground up by the federal government to assist families

struggling with water utility payments during and after the pandemic. Project BRAVO received \$1.9 million in LIHWAP funds in April of 2022 and by October of 2022 we spent more than 50% of our funds, just over \$1 million in water assistance. Project BRAVO is proud to be the first organization to provide more than \$1 million in water utility assistance in the state of Texas, ahead of other organizations that serve metropolitan areas with higher population density. Project BRAVO received additional \$1.5 million in LIHWAP funds in April of 2023 due to high performance.

In 2022, Project BRAVO also expanded the Career and Academic REadiness (CARE) Program through a new grant from the El Paso Community Foundation. Project BRAVO was awarded \$80,000 to support college and vocational education for people attending local public colleges. CARE Program participants have access to more financial resources during their academic journey thanks to the generosity of the El Paso Community Foundation.

Project BRAVO achievements in 2022 are thanks to our amazing team members and our board of directors who inspire us to serve. As you review this report, I hope you learn more about how Project BRAVO makes a difference every day in our borderland community!

## WEATHERIZATION ASSISTANCE PROGRAM

Weatherization is a service that makes homes more energy efficient, reduces energy consumption, and saves money spent on energy. Energy efficiency measures are installed such as attic and wall insulation and weatherstripping around doors and windows. A "whole house" approach is used to determine the measures that will be installed. The department also repairs furnaces, air conditioners, and provides HVAC startups for vulnerable households.



The changes Weatherization implements in homes make them more energy efficient and reduce utility bills.

One of our 2022 Weatherization and HVAC clients, Zoila, compared the furnace and duct work performed on her home as "an early Christmas present."

## WATER ASSISTANCE in El Paso

As part of the American Rescue Plan Act (ARPA), the federal government passed funding to help Americans struggling due to the pandemic. Millions were facing financial strains that caused food insecurity, hindered utility payments, and left people with hard decisions to make.

Part of the ARPA funds were designated to the Low Income Household Water Assistance Program (LIHWAP) to help provide a temporary water assistance program. Texas received \$92.4 Million to distribute in the state, with \$3.4 Million going to Project BRAVO to assist El Pasoans.

Even though it took almost a year for agencies to receive the funds, Project BRAVO started building a program as soon as Congress passed the act. We began building relationships with local water vendors and developing strategies to spend the highly restricted funds. The proactive approach proved worth it, as Project BRAVO was the first agency in Texas to provide \$1 Million in assistance to low-income famlies, vastly surpassing the large metropolitan areas in the state.

Our Housing Services assist families needing access to stable and affordable housing. Project BRAVO offers affordable apartment units, rental and housing counseling, and financial empowerment services.

Project BRAVO's Housing Department continues to be only one of two HUD Certified Programs in El Paso. Housing counselors are dedicated to assisting homebuyers navigating the fluctuating housing market as they purchased their first home, as well as families at risk of foreclosure. ## **CHANGING** *REAL* LIVES

While the pandemic became a threat all the way in 2020, our community continued to experience lasting repercussions in 2022. In late 2021, Jocelyne and her husband Ricardo came to Project BRAVO because they were falling behind on their mortgage payments. Ricardo was the sole provider of the family, and he had lost his job due to the pandemic. While our Housing Department was requesting forbearance and applying for the Homeowner Assistance Fund (HAF), our Career and Academic Readiness (CARE) Program helped Ricardo get a new job. The CARE Program offered him career and academic advise that resulted in Ricardo getting a job in a new career field.

Unfortunately, as Ricardo was in the process of getting his CDL, he passed away unexpectedly. Jocelyne could not take over the mortgage payments because she did not have a high school diploma and had very limited work experience. She knew she had to make a change to take care of her family.

Jocelyne reached out to the CARE Program to get on a path similar to the one her late husband was on. Jocelyne was able to get her GED and get a job that transitioned her out of poverty right before her forbearance ended.

While Jocelyne got her GED and entered the workforce, Project BRAVO provided her with supplemental resources such as gas cards, grocery cards, utility assistance, and more.

Shortly after her forbearance ended, Jocelyne was approved for HAF and her mortgage was brought current. In the summer of 2023, Jocelyne resumed regular payments on her mortgage using her income after less than a year in the workforce.
